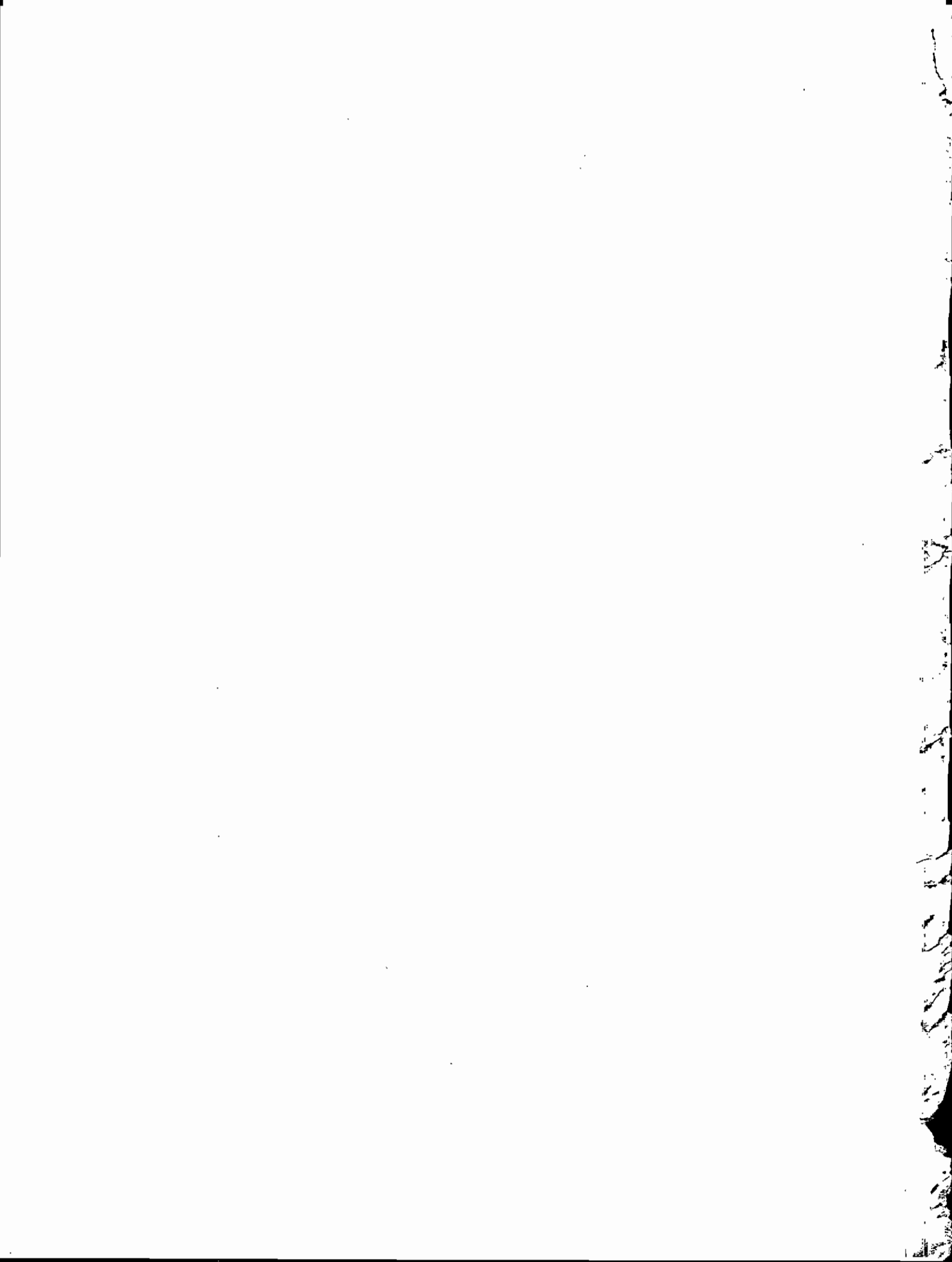

DEDICATION

This year the Town of Newmarket recognizes the arduous work and achievements of the over 200 members and the supportive staff of Club Chameleon by dedicating Newmarket's annual report to this outgoing group of teenagers.

Club Chameleon is a nonprofit Outdoor Adventure Club that was developed and staffed in association with the Newmarket Recreation Department. Although Club Chameleon is a non-profit program run under the Newmarket Recreation umbrella, it is solely responsible for its own funding and is completely run by a staff of volunteers. The program's financial support success is due to a team of individuals including; the marketing efforts of Aimee Gigandet, the solicitation of donations and corporate sponsorships by Jim Hilton, the grant writing efforts of the Friends of Newmarket Recreation and the continuing fundraising efforts of the Chameleon staff and teens.

The Club's mission is to provide an all inclusive environment for teen's ages 10-16 years with experiences outside of their surroundings. The Club's philosophy is to focus on outdoor wilderness trips in addition to community service and social events that will foster personal growth and self worth by providing opportunities to interact with positive role models.

Club Chameleon was founded and established in 2004 under the leadership of Anneliese Fisher, better known as "mama bear." In the very first year Anneliese Fisher received an award for Community Leader of the Year for her initiative in creating the program. After only its first year, the program was awarded the prestigious Willie Shellnut State Award for excellence in "innovative programming" from the State of New Hampshire Recreation and Park's Association in 2005.

Each month Club Chameleon runs a different outdoor weekend experience for approximately twenty Newmarket teens and ten staff for a three-day and two-night adventure. Currently the program is preparing for their 39th outdoor adventure. Of these 39 trips the activities have included canoeing, kayaking, mountain climbing, mountain biking, fly fishing, snow skiing, snow sledding, dog sledding, deep sea fishing, hiking and much more. Each member of Club Chameleon must participate in two training sessions and each teen signs a Full Value Contract before they are permitted to go on each trip. This contract serves as their signed commitment pledge to establish, in collaboration with their peers, the rules and expectations of each trip. This instills ownership of the rule making process and responsibility in the teens.

Since 2004 Club Chameleon has expanded its programming on a yearly basis to meet the ever changing needs of Newmarket's teenage population. In the spring of 2005 Chameleon Connection was created to afford teens the opportunity to participate in a one-on-one mentoring program with athletes from the University of New Hampshire. Currently there are over 40 teens that participate in this program. In the Fall of 2006 Club Chameleon was one out of twenty programs in the country chosen by the National Recreation & Park Association to facilitate a national program called Teens Outside which enabled a group of Newmarket teens to learn advanced rock climbing and

kayaking skills. In the summer of 2007 the teens participated in the National *TakeMeFishing* campaign where they were given the opportunity to learn from local masters the sport of fly-fishing. Now in 2008 Club Chameleon members have created "Teen Talk", a weekly meeting for teens to talk as a group about the stresses of everyday life.

When the teens of Club Chameleon are not out exploring the great outdoors they focus their efforts on community service. They believe in the "Pay It Forward" philosophy. If you reach out to help someone it has a ripple effect....one smile leads to another smile, one good deed leads to another good deed. This is the way they lead by example. For the past few years this group of teenagers worked on turning the Hilton Winn Farm into an outdoor environmental camp for kids. They have volunteered several weekends to work on the farm in order to create a learning environment for younger children.

This inspiring group of teenagers has volunteered on numerous occasions to mentor the younger generations here in Newmarket. They spent several days planning and teaching literacy to a group of pre-school age children in the Head Start Program. Each teen paired up with a child in the pre- school to organize and perform a literacy production of the very popular children's book *The Very Hungry Caterpillar*. These teens also volunteered to speak to several groups of pre-teens at the elementary school about the advantages of staying off drugs and alcohol, and shared stories about the positive effects of participating in outdoor education and adventures.

Just this past year the teens spent three full days at the Heritage Festival as the work force to help everything run smoothly. From sun up to sun down you could spot a member of Club Chameleon volunteering to set up tents, chairs, booths, tables, carry supplies, clean, sweep and even take out the trash. There was no job too small or too big for this group.

When the runners came to race in Newmarket for the Great Bay Marathon and for the Old Home Weekend 5 K Road Race it was Club Chameleon that was running to help them. The teens helped to set up for the race; they worked the water stations and helped to direct the runners. From start to finish Club Chameleon was there to volunteer their time and efforts again hoping to pay it forward.

The Newmarket Town Officials recognize that the teenagers of Club Chameleon have a genuine desire to be active members of this community and we appreciate your hard work. We know that volunteering your time shows your commitment to your philosophy and can assure you that your efforts have made a difference. We also recognize the work it takes to facilitate this program and we want to thank all of the Club Chameleon staff, especially "mama bear" for volunteering your time to make this program such a huge success.

Although Club Chameleon follows the "Leave No Trace" philosophy while exploring the outdoors, they are certainly making their mark by leaving a trace of leadership and community spirit. This trace is turning a lot of heads as communities across the country look to model the recreational diversity found right here in Newmarket, New Hampshire.

Report of the Town Council

Over the last year, the Town of Newmarket has faced numerous challenges, and has, as usual, come together as a community to address them in a respectful and productive manner.

In April of 2007, we faced another historic flood, and as in May of 2006 the volunteer Fire Department and community rallied together to respond. Many thanks to the Fire Department, and those individuals, businesses, volunteers, and staff who helped the Town recover again.

Prior to the long-planned retirement of Town Administrator Alphonse Dixon in September, the Town Council established a Town Administrator Selection Committee to identify finalists for the position. The Committee included public members, union and non-union employees, Durham Town Administrator Todd Selig, and Town Councilors. After reviewing more than 40 resumes and interviewing nine candidates, the Committee recommended three finalists. The Town Council interviewed two of the three, and hired Edward J. Wojnowski as our new Town Administrator. Mr. Wojnowski, a Newmarket native, impressed the public and Town Council with his candor, positive attitude, and desire to tackle our many projects. Welcome Ed!

In the late fall, the Town Council received the final report of the forensic auditor Jeff Graham of Graham and Graham. The report identified significant errors and concerns about the financial expenditures, management and oversight by the previous Town Administrator, Finance Director, and auditor, Paul Mercier of the Mercier Group (the report can be viewed at the Town website or picked up at the Town Hall). The Town Council immediately referred the report and the auditor's conclusions to the Office of the New Hampshire Attorney General and to the Rockingham County Attorney, who continue to investigate any possible criminal charges. In addition, the Town Council established two committees to support implementing the report's proposed reforms. The Forensic Audit Follow-Up Committee's work is just getting underway as this report is written, and will focus on evaluating the transactions from the FY2005-06 that did not contain sufficient documentation to help determine if those expenditures were appropriate. The Municipal Audit Committee is a permanent standing committee who will support and provide oversight for the annual audit of the Town's finances. Newmarket is the first town in the state to create such a committee. The Town Council is actively addressing the specific recommendations of the report, including drafting new policies and revising existing policies. In addition, in December the Town Council authorized the hiring of a full-time staff accountant to support further segregation of staff responsibilities and to meet the increased workload resulting from meeting the current accounting principles for municipalities. Updated status reports on the Town's progress in addressing the forensic auditor's report can be found at the Town website.

I would like to extend the Town Council's appreciation to Mr. Wojnowski and Don Parnell, the new Finance Director, and all staff for actively supporting and implementing the changes necessitated by the report. The Town Council and Town employees are fully committed to restoring your trust in our Town government.

This year saw the successful conclusion of the initial part of Phase II of the Downtown Revitalization Project. The 'bowl' portion of Route 108 now has new water and sewer lines, better underground drainage, improved sidewalks, better parking, and new street lighting. The

Town has installed the underground conduits for moving the overhead telephone, cable, and electrical wires, which is expected to be completed by Public Service of New Hampshire, Comcast, and Verizon in 2008, at which time the telephone poles will be removed. The Town appreciates the patience of the residents and businesses along that portion of Route 108. 2008 will see the heart of downtown under active construction and repair from April through November. I encourage Newmarket citizens to support their downtown businesses during this difficult time by patronizing their businesses.

The Town Council continued to support the private non-profit Newmarket Community Development Corporation's (NCDC) efforts to redevelop the remaining mills in downtown. The Town, through the work of the Downtown TIF District Committee, and NCDC have cooperated on the pending acquisition of two critical properties necessary to support current and future development of the mills. Further, the Town and NCDC have agreed on a framework proposal for providing parking to support the mill redevelopment. (As a member of the NCDC board of directors, I recused myself from any Town Council discussions or votes on matters related to the NCDC.)

Significant progress continues to be made on meeting the long-term public drinking water quality and quantity needs of the Town. The Town is actively negotiating the acquisition of an undeveloped property for installation of a future well for public drinking water. This well could serve as a supplemental or back up supply for the Town. We hope to have that property acquired by mid-year 2008. In addition, the Town continues to work with the consulting firm of Emery and Garrett to evaluate the most economical way of 'artificially' recharging our current aquifer with water from the Lamprey River. Two alternative routes, one from the Town of Lee and one from the Sliding Rock area in Newmarket, are being evaluated. The initial pilot test of the proposed system indicated that aquifer filtered the river water to meet current and expected drinking water standards. This alternative could eliminate the need to retrofit the drinking water treatment plant (saving \$15 million or more), while ensuring the Town has sufficient water year round.

On a personal note, I have enjoyed serving Newmarket as a Town Councilor for the past six years, and for three of them as chairman. As I will not be running for re-election in May, I wanted to express my gratitude for the opportunity you gave me to serve this town. Newmarket is a great community, with impassioned residents who care deeply about the past and future of this town. We are blessed with many active individuals who invest their time and energy in improving our Town. If you are not already engaged, I encourage you to participate in one of our many civic organizations, town boards, or elected offices. As I have learned, it is a rewarding and challenging experience.

ASSESSING DEPARTMENT

For the Town of Newmarket, the past year proved challenging – also not withstanding some of the controversy and the flooding our real estate values have started a downward trend.

According to the State, marketing time statewide increased 25% to an average of 134 days and 10% fewer homes sold in 2007 versus that in 2006. As to prices; Rockingham County experienced the worst in the state with an approximate 5% decrease. This drop in the market mirrors my findings for our town. The figures represent an average and do not mean that all property sale values experience the same decline, some actually increased but most did not.

I believe this trend may continue for a few months, however, should the economy remain strong and interest rates low we could see a slow and steady rebound before next year.

CERTIFICATION: The Town of Newmarket has passed its 5-year audit for tax year 2005. The next certificate year is 2010. The audit or “Assessment Report” can be viewed on line at the State Dept. Revenue website: www.revenue.nh.gov/property_tax/index.htm click on Assessment Report. For those interested in other statistics comparing Newmarket with other communities can also be viewed at this site. For those not having computers, you can obtain a paper copy of our Assessment Audit Report at the Assessor’s Office.

VERIFICATION: For State Certification purposes, the Assessor’s Office plans to visit all properties at least once every five years. The office is committed to 100% accuracy of our records. Although a difficult task, we feel that this verification process goes a long way towards achieving this goal. During this year, we hope to visit another 20% of our base properties.

REVALUATION: The State is also requiring that assessments be revised at least once every five years to reflect fair market value. As taxpayers know, the Assessor’s Office has taken a proactive approach to prepare for our next certification audit. During the past few years, certain revisions have been made in preparation of this certification. These revisions minimize the impact of any final revaluation.

EQUITY: State statutes require that the Assessor review the assessment rolls every year to ensure equity. All properties should be proportionately assessed so that no individual pays any more or less than their share of the tax burden. As a result, the Assessor may adjust values of different types, classes or properties when significant differences exist.

ASSESSMENT RATIO: As of April 2007, properties were assessed at approximately 90% of their fair market value, as a matter of reference, our ratio last year (2006) was 86%.

TAX RATE: The year 2007 tax rate was \$21.20 per thousand of assessed value.

The 2006 tax rate was 20.49. The difference of 71 cents per thousand represents a 3½% increase from the previous year.

ABATEMENT REQUIREMENTS: Legally, a taxpayer can challenge the assessment each year and has until March 1st following the final tax bill to challenge in writing or, preferably, file an official abatement form (available at the Tax Collector's Office). Requirements are explained on the form.

EXEMPTIONS: Property owners may be eligible for certain exemptions on their property. If you are elderly, disabled, blind, a veteran, veteran's widow or unable to pay taxes due to poverty or other good cause, you may be eligible for tax exemption, credit, abatement or deferral. For details and application information, contact the Assessing Office at 659-3073. Criteria for all exemptions and credits can be viewed on our Town website www.newmarketnh.gov - see Assessing Department link

Please keep in mind that values are only periodically updated.

DEPARTMENT OF BUILDING SAFETY

In 2007, two permits were issued for single-family homes and no permits were issued for condominium units. The number of permits for single-family homes and condominium units has dropped steadily going from a high of 114 permits in 2001 down to 2 permits this year. The number of permits for residential alterations and additions remained about the same as the last two years.

People often ask what types of projects require a building permit. A few examples of projects where building permits are required are for any work involving structural changes to a building, finishing or remodeling rooms and other areas such as basements and attics, installing new windows or vinyl siding, and roofing. Any time that you add an outside structure, such as an addition, garage, deck, in-ground or above-ground swimming pool, or a shed, a permit is required. Also, any electrical or plumbing work requires a permit. Accessory apartments (aka in-law apartments) require Zoning Board of Adjustment approval prior to the issuance of a building permit. If you are not sure whether you need a permit, please contact our office. Inspections are required for certain stages of every project. We would like to assure you that life safety continues to be the primary concern of this department and inspections of your project help to ensure your family's safety.

When applying for permits, please remember to allow time for your application to be reviewed. I recommend that you allow at least three weeks for the approval of a building permit. Although the turn-around time is usually a little faster than that, there are times when I have many other permit applications on my desk ahead of yours for review, as well as a busy inspection schedule, and Health Officer and Zoning Administrator duties. Other circumstances, such as requiring further information from you on your plans, could occur which would also cause a delay in your approval. Be sure to allow time for these situations, when applying for a permit, to avoid getting into a time bind with your project.

If you are planning a building or remodeling project, I am always happy to sit down with you and go over your plans, review building codes, and answer any questions you may have. Please call ahead for an appointment, at least 24 hours in advance, as my schedule fills up very quickly.

I have enjoyed working for the townspeople of Newmarket and look forward to the year ahead.

NEWMARKET FIRE & RESCUE

This past year the department responded to 1,060 calls, compared to 1,020 in 2006, this represents a 1% increase. There were 596 medical calls and 464 fire calls. The department currently has 54 volunteer members.

For the second consecutive year, Newmarket experienced another flood. I would like to thank all residents that assisted this department with the filling of sandbags, food preparation at the station, and lastly, cooperating with all the evacuation plans that needed to take place.

This past year the state as a whole, saw 437 wildland fires for a total of 212 acres that were burned. Rockingham County had 22 fires, which totaled 16 acres. To reduce the risk of wildland fires, please contact the Department to determine if a permit is required before doing any outside burning. Permits are issued Saturdays and Sundays from 5:00 p.m. to 6:00 p.m. at the fire station.

The Department continues to do educational and fire prevention activities for various groups in the community, such as the Boy Scouts, Girl Scouts, schools and local businesses. The Department is always giving tours of the fire station.

This past year the town purchased two new AED (Automatic External Defibrillators) one is located at the Town Hall and the other is at the Community Center.

Newmarket Fire & Rescue encourages all homeowners to properly number their houses. This greatly reduces confusion and time spent looking for your home during an emergency situation. We recommend using green signs with reflective numbers at the end of your driveway. These signs are available through the Fire Department at a low cost. Please contact us to purchase one and we will install it for you.

NEWMARKET CONSERVATION COMMISSION

The Conservation Commission hosted the extremely popular boat tours on the Lamprey River as part of the annual 2007 Newmarket Heritage Festival. The Commission also staffed an educational exhibit at the Schanda Park next to the boat launch as part of this event. In addition to educational programs, the Commission commented on several proposed development projects that affect wetlands and other natural resources. Some of the issues that the Commission considers when reviewing development proposals include protecting surface and ground water quality, managing storm water runoff, protecting wetlands and wildlife habitat, and reducing the amount of impervious surfaces.

A major part of the Commission's annual responsibilities include stewardship of town-owned conservation lands, which include more than a dozen parcels that total 359 acres. Stewardship activities include creating and maintaining parking areas and trails, walking boundaries and putting up signs, building educational kiosks and benches, managing habitats, and monitoring public uses. The Public Works Department is a great partner with the Conservation Commission and helps with many aspects of stewardship including plowing parking areas and mowing trails. Public Works also mows the Wiggin Farm field in September. Mowing once a year keeps the field in grassland, while allowing birds, turtles, deer, and other wildlife to use the field during the breeding season for food, cover, and nesting.

Another great partner with the Conservation Commission are the Newmarket Eagle Scouts. In 2007, Eagle Scout Sean Riley completed his scout project by coordinating the building and installation of two beautiful wooden benches and installing xx interpretive signs along the hiking trails on the Wiggin Farm Conservation Area. Eagle Scouts have completed several other projects at Wiggin Farm during the past few years including laying out hiking trails and constructing a walking bridge over a wetland. The Conservation Commission appreciates this successful partnership with Newmarket's Eagle Scouts and looks forward to more collaboration.

As part of the Town's land stewardship responsibilities the Conservation Commission conducted annual monitoring walks on two town-owned conservation areas (Wiggin Farm and Piscassic River-Loiselle) and two town-held conservation easements (Silverman-Schneer and Nostrom). In addition, the Town continues to partner with the Southeast Land Trust of NH, which conducts an annual monitoring visit of the town-held Hilton conservation easement.

The Conservation Commission approved \$75,000 from the Conservation Fund (these funds come from 50% of the Land Use Change Tax) toward the acquisition of a conservation easement on the 32-acre Dodd Farm at the corner of Neal Mill Road and Grant Road. The Southeast Land Trust of New Hampshire will hold the easement and raised the additional funds for the easement including a major grant from the Farm and Ranch Land Protection Program. This property has 1,300 feet of frontage on the Piscassic River.

NEWMARKET OPEN SPACE COMMISSION

In May 2002, Newmarket residents voted overwhelmingly in support of a \$2 million bond for the acquisition of land to protect the town's rural character and natural resources and to provide land for outdoor recreation, including athletic fields, or other public purposes. The Town Council established the Open Space Commission (OSC) in 2002 and charged it with identifying and negotiating the acquisition of land and conservation easements for open space, resource conservation, athletic fields and other public purposes. The OSC is working with interested landowners to acquire lands or conservation easements to benefit current and future residents of Newmarket. The Commission has nine members with staggered three-year terms. It has a representative from the Town Council, Planning Board, Budget Committee, and Conservation Commission, and five additional at-large members. The membership of the 2007 Commission was Bill Arcieri, Peg Chaffee, Hunter Brownlie (Vice-Chair), Elizabeth Dudley (Conservation Commission Rep.), Brian Hart (Council Rep.), Gary Jablonski (Budget Committee Rep.), Drew Kiefaber (Chair), Janice Rosa (Planning Board Rep.), Andrew Share (Secretary).

In 2007, the Open Space Commission assisted in a sixth land conservation project. The Southeast Land Trust of New Hampshire is working with the Dodd's family to purchase a conservation easement on a portion of the family farm. The easement prevents residential and commercial development on 32.5 acres in perpetuity, while the land remains in private ownership and will remain available for farming. This property has 1300 feet of shoreline on the Piscassic River and scenic views from Grant Road. The property will be open for public passive recreation as it has been in past. The easement cost of \$370,000 is less the appraised value, hence a 'bargain sale'. The funding for this project is as follows: \$175,000 from Town funds (Open Space bond and Conservation Commission), \$192,250 from the Farmland Protection Grant Program and \$26,000 from private fundraising by the Southeast Land Trust.

Since its inception, the OSC, in partnership with the Conservation Commission, and with significant support from other agencies and groups, has conserved 430 acres. Together we've leveraged \$1.845 M of Town Funds with \$1.828 M of federal and state grant funds. These projects include a mix of fee-ownership conservation areas and conservation easements on private lands. The OSC and CC are working together on public use and habitat management plans, trails, parking areas, and information kiosks for these conservation lands.

The School Board previously requested \$500,000 of the Land Acquisition Bond funds to purchase land for a future school site and athletic field complex. Proposed land acquisitions abutting the current Jr/Sr. High School failed in the 2007 School Warrant. The need for athletic fields for student and public (youth and adult) recreation remains and is a priority.

The public, including interested landowners, are welcome to attend the OSC meetings held in the Town Hall at 7 PM on the 2nd Monday of March, June, Sept., and Dec. Discussions with landowners interested in conserving their land are kept confidential until there is a mutual agreement to proceed with an acquisition.

Report of the Planning Board

In 2007, the Planning Board saw a slowdown in development and in the number of applications in comparison to recent years. The Board spent a considerable amount of time reviewing a handful of applications. Five site plans were approved, most notable was the fifteen (15) unit mill conversion and redevelopment of the 'Selectwood' building on Bay Road. Also approved were a car detailing business on Beech Street Extension, a container storage business on Route 152, conversion of office space to a new residence at the Newmarket Mini-Mart at the corner of Gerry Avenue and Route 108, and a conversion of a two-unit rental duplex to condominiums. The Board saw several applications that had been considered at a number of meetings, but were withdrawn for various reasons. In December, the Planning Board was notified of the intent of The Nature Conservancy to purchase the 19 lot Kwaks Subdivision on Wadleigh Falls Road which had been conditionally approved in July of 2006.

Throughout the year, the Planning Board continued to work with the Newmarket Community Development Corporation (NCDC) regarding the mill redevelopment. The Board worked through several sessions on the proposed Dunkin Donuts on Route 108, at the entrance to the Newmarket Corporate Business Park.

On the administrative front, the Planning Board adopted a comprehensive Open Space and Conservation Plan written by Ellen Snyder of Ibis Wildlife Consulting. The Planning Board also prepared and endorsed two Zoning amendments pertaining to shed accessory structures, and a revised Aquifer Overlay District. These ordinances were forwarded to the Town Council and adopted in late Fall of 2007. The Planning Board also started looking at changes to the Subdivision and Site Review Regulations, including cistern regulations for fire protection in future developments that are not tied into the Town's water system. Peter Roy, John Badger and Planner Diane Hardy spent considerable time during the fall representing the Planning Board on the CIP Committee.

In an effort to help people better understand the planning process the Planning Board made some changes in the way it does business. Our agendas have been reformatted to make it easier to understand the type and status of each agenda item. Member John Badger created a very informative PowerPoint slide presentation to help convey the purpose and charge of the Planning Board to the public.

During the year, there were also changes in the composition of the Planning Board. Peter Roy, Janice Rosa, and Judith Carr were elected to the Board in May. Robert Fillion left the Board after many years of service. Former Chairman George Willant returned to the Board as an Alternate member.

The Planning Board continues to receive great service from its staff. Planner Diane Hardy continues to fearlessly guide us during meetings, providing recommendations that are truly invaluable in our pursuit to plan in a comprehensive and cohesive manner. The Board is also fortunate to have Susan Jordan to help both Diane and the Board in administrative manners. She does a great job keeping the Planning and Zoning office running smoothly on a day-to-day basis. Lastly, but not least, I would like to acknowledge Erica Spechuilli, the Board's Recording

Secretary, for her great work. She is second to none in her ability to transcribe our meeting minutes with amazing accuracy and clarity.

It has been my pleasure to serve the Town of Newmarket and the Planning Board this year as Chairman. I would like to thank Vice-chair John Badger for helping me throughout the year. He has offered valuable advice and has often pointed me in the direction of items that need attention.

2007 PLANNING BOARD APPROVALS

Subdivision Review requested by Haven J Wiggin II & Carolyn T. Wiggin at 6-8 Forest Street, Tax Map U2, Lot 177, R3 Zone. The proposal was to convert the existing two units into two condominiums.

Site Plan Review and Special Use Permit requested by Lamprey Falls, LLC at Bay Road, Tax Map U2, Lots 359, 360 & 361, Zone M1. The proposal was to convert the former "Selectwood" building into fifteen residential units.

Site Plan Review requested by Linda M. Hopey/Frederick & Cristal Faucher, at 25 Beech Street Extension, Tax Map U3, Lot 148, Zone M2. The proposal was to open an auto detailing shop.

Site Plan Review, requested by Chinubhai Patel, at 44 Exeter Road, Tax Map U3, Lot 139A, Zone M2. The proposal was to convert 1500 +/- sq. ft. upstairs into a two-bedroom apartment.

Site Plan Review requested by Solon Realty Co, LLC at 438 Wadleigh Falls Road, Tax Map R6, Lot 50, Zone B3. The proposal was to allow former construction company and gravel pit to be used for operation of storage trailer and container rental business.

Newmarket Police Department

In 2007, the Newmarket Police Department answered 19,709 calls for service, with nearly 8,300 attributed to the Newmarket Police Department and the remainder to the other agencies we serve through our dispatch center. We investigated 131 reportable motor vehicle accidents, affected 241 custodial arrests and conducted 313 criminal investigations. While the statistical numbers fluctuate from year-to-year, we are seeing an increasing demand for police and dispatch services from the Town of Newmarket and the area communities we dispatch for.

The trend since calendar year 2000 has been that the officers are handling cases that are more complex and time consuming and we are involved in more cases, which require follow-ups, taking the officers away from routine patrol duties. Some of the areas where we have seen increases are sexual assault, burglary, sex offender registry and tracking, and in background checks. The opposite is true for officer-initiated activities like motor vehicle stops, which have declined an equal percentage from 2000. To ensure that the areas of town where we get most of our traffic related complaints are adequately covered we've instituted direct patrols where officers are assigned to be in these areas during peak activity times.

Officers Christopher Bashaw and Daniel Byers joined our team in the spring months and Dispatchers Pat Donnelly and Zach Wedgeworth came aboard during the summer months. At this point in time we are fully staffed with some very dedicated and competent personnel. I'm excited for the opportunities this presents us to serve the community.

We're continuing to redraft our Standard Operating Procedures to National Accreditation Standards. Achieving accredited status is a huge undertaking but we're working toward that goal. Standardizing procedures is the first step in the process and will make our agency better even if we haven't received recognition as an accredited agency.

Several of the staff members have been working on Emergency and Incident planning to pre-plan for critical incidents which will help us to better coordinate responses to potential incidents in Town. We're meeting with officials from the school district next week to begin to develop procedures that coordinate our efforts.

The Town's communications equipment received a complete upgrade this year. This included the dispatch center at the police station and our remote transmitter site on Zion's Hill. I'm happy to report that the last of the four radio transmitters, (The Fire Base) on Zion's Hill will be replaced this spring through a grant received by the State of NH. This amounts to a soup to nuts upgrade of our entire town radio communications network. We're entering into a service contract agreement within our operating budget to maintain the system, and we've itemized all of this equipment with the CIP Committee to prepare for future replacement.

This brings the total to about \$450,000 worth of equipment we've received through grant funding in the last four of five years. The next step will be to provide live data to the police cruisers and the capability to eventually provide this to fire and ambulance apparatus. The equipment required for this next upgrade I hope to purchase without taxpayer funding in the coming year.

For the first time, the Newmarket Police Department was part of a regional enforcement effort targeting underage drinking and liquor sales enforcement. This enforcement action teamed the Newmarket, Stratham and Newfields Police Departments, and utilized compliance checks at local businesses, and targeted teenage drinking sites. This effort was first funded by the NH Highway Safety Agency and was successful and may be repeated around the State. I am happy to report that Newmarket had very few compliance violations by the local businesses compared to neighboring communities.

We want to thank the members of the community for the support we receive on a daily basis. We remain committed to providing quality police services to our residents. Please do not hesitate to contact us at any time.

NEWMARKET PUBLIC LIBRARY

The library website is Newmarket.nh.lib.us. Please visit our site to check on our new materials, general information, or to access the online catalog from home. You may now renew materials online. Ask for the procedures and a pin number at the circulation desk.

We are now in the second year of a program offered by the State Library called New Hampshire Downloadable Audio Books. Patrons of the library can now explore the growing collection of audio books and use your library card to download the books to your computer, transfer them to an MP3 player, or burn selected titles onto a CD for listening on the go.

We provide free internet access and have five personal computers for patron use (four in the adult area and one in the children's room). We also have wireless access available and one wired port is available for a laptop in the reference room.

If you cannot find the material that you need at our library, complete an Interlibrary Loan (ILL) form available at the circulation desk. Material is borrowed from other New Hampshire libraries. Delivery is via the New Hampshire State Library van service. Deliveries are on Tuesday. It usually takes about a week to receive your request, if available.

The library has a computer in the reference room, which is dedicated solely for reference use and access to the online databases provided by the State Library. These databases can also be accessed remotely with a valid library card. This free collection of full-text databases covers areas such as general reference, business and health resources, genealogy, history and biography, magazines and newspapers. For example, we can provide

- Students at all grade levels with valuable curriculum related resources
- Consumers with the medical resources necessary to make informed decisions about their health care and treatment options
- Genealogists with the tools necessary to explore their family history
- Lifelong learners with resources to allow them to investigate areas of interest

We are celebrating all things Australian this summer with the "G-Day for Reading" summer reading program. So, think kangaroos, koalas, coral reefs, boomerangs and didgeridoos. Let your library become a gateway to Australia and visit our neighbors "downunder." The preschool story hour is ongoing: stories, crafts and a good time!

Thanks again for the generous donations to the library during the course of the year. The Trustees would also like to thank the Public Works Dept. for the care of the walks and grounds and assisting in building maintenance. The Newmarket Gardeners continue to maintain our library garden and seasonal decorations enjoyed by staff and patrons alike!

PUBLIC WORKS DEPARTMENT

The Department had another busy year. As everyone will recall, in April our community was devastated with another flood event. Much of the town's infrastructure was damaged or destroyed. This Department made permanent and temporary repairs to many streets, sidewalks, and drainage lines and pumps stations once again. This work was completed within just days of the water receding. All permanent repairs were completed by June. Once again, I would like to thank everyone in our community who assisted this Department with manpower, equipment, and supplies, or by volunteering to fill sand bags at the Macallen Dam.

The following roads were paved and some were reclaimed: Bay Road, Grant Road, Mastin Drive, Grape Street, Elder Street and Forrest Street. Once again, Bell & Flynn of Stratham, NH was awarded the Paving Program contract. Due to the dramatic rise in costs of fossil fuels, not as many streets could be paved as scheduled in the CIP. This will affect the paving schedule in the years to come unless additional funding is allocated for the paving program.

Bestway Disposal Services, Inc., of Epping, NH continues to collect our solid waste and recyclables. Should residents have questions, Bestway's phone number is 778-2116. Please remember to have your rubbish and recyclables at curbside prior to 7:00 a.m. on your scheduled pick-up day. Curbside recycling decreased from 820 tons in 2006 to 791 tons in 2007. Pay-per-bag increased from 844 tons in 2006 to 925 tons in 2007. The Transfer Station is currently open every Saturday from 7:30 a.m. to 4:00 p.m. Coupons may now be purchased by check\money order only at the Transfer Station. Coupons are still available at the Town Clerk's office located in the Town Hall.

The Water Division continues working with Emery & Garrett on a pilot study for artificial recharge of our aquifers and exploring various locations in our community for new sites for bedrock wells. It is our goal to identify and develop a new source for our community. The process itself is expected to take several months and once an adequate site is identified, we should be able to bring it online within two (2) years.

The Wastewater Division is currently working on an Infiltration\Inflow Study, which is expected to be completed in June 2008 as a part of our Administrative order from USEPA. The results of this study will recommend upgrades to the collection system to reduce infiltration/inflow.

Lacrosse is becoming the fastest growing sport of the new millennium and Newmarket Recreation is doing whatever we can to make sure we're on the ball with this sport. Due to the previous year's success, Newmarket Recreation brought back Hershey's Track & Field again last year and ended up recruiting over 20 kids to participate in the 2007 summer games. Hershey Track & Field Games is an exciting track and field event to promote active lifestyles, sportsmanship as well as provide an opportunity for kids to be the best that they can be. Even our 5 & 6-year old T-ball program grew in 2007. Even if you haven't stopped by on a Wednesday night, its quite a sight to see watching 8 teams comprised of this age group play ball! Our newest programming additions last year would be our Peek-A-Book program geared to toddlers & preschool age children, our Beginning Ballroom Dancing for adults and our partnership with the Exeter Hospital Mobile Health Care Services. If you haven't heard, on the 3rd Monday of each month, Exeter Hospital Mobile Health Care Services medical van will be on-site from 1pm - 3pm to offer a variety of FREE health screens to anyone who wishes to have a screening done (i.e. cholesterol, ABI, blood sugar) and/or whatever screenings they may be focusing on that month. Do you have a medical question you would like to ask the visiting doctor? According to the staff at Community Healthreach, no reason is too small to stop by. Newmarket Recreation is happy to finally announce the opening of Phase 1 of our Sunrise Sunset Activity Center for our active 55+ population. *Get Up Get Active Be Alive at 55!* The center is located at 2 Terrace Drive - the old ambulance building. We would like to thank the Newmarket Housing Authority for funding the majority of the *Phase 1* project. Sunrise Sunset *Phase 1* included: a state-of-the-art kitchen, which will house the Rockingham County Meals on Wheels program; a 400 sq. ft. community room which will be used for a variety of programs such as crafts, cards, congregate & small social networking events; a small multi-use private office which will be used for foot clinics, tax help, etc.; and a newly paved one-way easy in & out parking. It is our wish to begin general activity programming in the facility in February of 2008. Phase 2 of the Sunrise Sunset Center will include a 1500 sq. ft. multi-use function space and is projected to start construction in July of 2008. Again, we hope to expand senior programming all together after *Phase 2* of the center opens. Our last bit of goods news is we again applied for a *New Hampshire GraniteCare Senior Wellness Grant*, which if granted, will help pay for a 6 month Tai Chi wellness program for our senior population in 2008.

REC the Pre-Teens and Teens of Newmarket in the Club Chameleon Way

We are happy to announce that at the end of 2007 we had over 215 registered in the Club Chameleon program, that's 40 teens up from last year. As you may remember, we reported last year that the Newmarket Recreation's Club Chameleon was designated as one of 20 Teens Outside! pilot sites by the National Recreation and Parks Association and the Outdoor Industry Foundation. By participating in the Teens Outside! program in 2007, our Club Chameleon teens participated in advanced kayaking and rock climbing, in addition to the Great American Back Yard Camp Out, various community service projects, learned how to fly fish and went white water river rafting as part of another national campaign, entitled *TakeMeFishing*. The rock-climbing kids also mentored down their rock climbing skills to local area 4th graders. After completing this year long Teens Outside! adventure, our Club Chameleon teens wanted to celebrate their achievements and share them with younger kids to let them know how great Club Chameleon is and how it has changed their lives and why they love the outside world around them. It was decided that we would organize a "tie-in" assembly between the Newmarket Elementary School's celebration of Red Ribbon Week and Newmarket Recreation's Club Chameleon program. We believe Newmarket's Club Chameleon offers the perfect alternate activities for your kids to get involved in rather than getting involved in drugs! For example, *Chameleon teens don't get tied up with drugs... they get tied into carabineers and go rock climbing!* The Chameleon Connection Mentoring Program with the athletes of the University of New Hampshire also grew by leaps and bounds. By the end of the 2007-year Club Chameleon connected 45 teens with positive role models from the Life Skills program at UNH. Also in

November of 2007 the program received a \$5000 grant from the NH Charitable Trust Foundation. The grant will be used for various Chameleon Connection activities, as well as one-on-one mentoring activities. Veterans Memorial Trust Committee

The Newmarket Veterans Memorial Trust Committee has been working under the auspices of Ordinance #2002-10 criteria established by the Newmarket Town Council to oversee the establishment, maintenance, care and improvements of veteran's memorials in the Town of Newmarket.

The Trust continues the arduous task of gathering and verifying names those who were Newmarket residents at the time of armed conflict for inclusion on a new memorial. With the help of the American Legion and Legion Auxiliary and other members of the community, we have created a book of compiled data containing names, branch and date of service. The book is on view at the Newmarket Public Library and at the Newmarket Town Clerk's Office. We ask that our citizens review the list, and contact our Committee by letter with any corrections.

As the American Legion informed us that the Honor Roll on the bandstand was never intended to be permanent, our task is to create a new memorial, which will list the names of World War II veterans and continue forward. Upon completion of the new monument the old Honor Roll will be turned over to the Newmarket Historical Society.

The Newmarket Public Library has graciously agreed to let the new memorial be erected at their site. We continue the design process, and hope to present concepts to the community in 2008.

A sign to honor all our Newmarket Veterans will be installed at the Main Street bridge that spans the Lamprey River. We were disappointed that we did not hit our target date, as our first design was not approved by the State Department. The design was reworked, approved and will now be erected in 2008.

The Trust has established Riverside Cemetery as a possible site for a small monument in the near future. This monument will again honor all our veterans, and will also serve as a podium for speakers for Memorial Day services.

The Trust has overseen the professional cleaning of current memorial plaques. These plaques are made of metals which are difficult to work with, and expensive to maintain.

Veterans History Project

This year the Trust became a partner with the Veterans History Project. This is a project of the American Folklife Center of the Library of Congress. Under their tutelage, we capture the oral stories and share in the experiences of our veterans. For those who want more information please log onto their website (<http://www.loc.gov/folklife>) or contact any member of the Trust.

Our tapings on Channel 13 have begun. We have interviewed Herbie Philbrick, Richmond Walker, and Doctors Veron Brown and Forbes Getchell. This will be an

ongoing project beginning with our World War II vets and continue to include present day conflicts of Afghanistan and Iraq.

Funding

Our Committee has been graced by the community in supporting our efforts for the veterans. Our budget requests were passed by voters. Without their compassion and support, we would not be able to accomplish our goals. We thank you.

In 2005-2006 the sum of \$5,570 was approved. In 2006-2007 the sum of \$5,595 was approved. In 2007-2008 the sum of \$10,000 as a Warrant Article was approved. As of 8/29/07 the Trust Account has \$6,333.98.

Expenses

Expenses to date: Cleaning of plaques - \$5,175 (2005-2006)
Engineer Report on the Bandstand Memorial - \$800 (2007-2008)

At this time we can attest to a balance of \$9,200 from the year 2007-2008 and the amount of \$6,333.98 in the Trust account. This gives us a balance of \$15,533.98. (Ongoing project expenses to be taken from these funds).

It is definitely a pleasure to serve on the Veterans Memorial Trust Committee.

An Update from Washington

Last year, the House of Representatives passed many important measures that affect our lives here in New Hampshire. From lowering the cost of student loans, to raising the minimum wage, to protecting middle-class families from the Alternative Minimum Tax, Congress addressed a wide range of issues that will benefit New Hampshire families.

To help families afford the rising costs of higher education, we passed the College Cost Reduction and Access Act, which will cut interest rates in half for federal student loans, and save a typical student in New Hampshire \$4,430 over the life of a loan. The bill will also increase funding for Pell Grants for low-income students and provide loan-forgiveness for talented students who pursue public service fields like teaching or emergency response.

Congress passed legislation to protect 23 million families from a tax increase of up to several thousand dollars this year under the Alternative Minimum Tax. In July, we raised the federal minimum wage, increasing it from \$5.15 to \$7.25 an hour by 2009. At the same time, Congress also passed tax credits for small businesses. To find out how businesses can take advantage of the new tax benefits, visit www.sba.gov or contact my office at (603) 641-9536.

With energy prices rising, Congress increased the fuel efficiency standards for vehicles for the first time in thirty-two years. I'm also pleased that we passed an increase in funding for the Low-Income Home Energy Assistance Program (LIHEAP), which supports New Hampshire's Fuel Assistance Program. If you or someone you know needs help affording the cost of heating fuel this year, please contact the New Hampshire Office of Energy and Planning at (603) 271-8317.

It was a busy year in my New Hampshire offices in Manchester and Dover as well, where we assisted over 1,200 individuals with inquiries to federal agencies including Social Security, Medicare, and the Veterans Administration. Last summer, when there were huge delays at passport offices around the country, my staff helped more than 200 people get their passports on time. To apply for a passport, visit travel.state.gov and follow the online instructions, or see the Frequently Asked Questions section of my website for more information.

Representatives from my office regularly visit towns across the First District to assist constituents in working with the federal government. For more information about the services that my office provides, please visit: www.shea-porter.house.gov.

Strafford Regional Planning Commission 2007 Report

Strafford Regional Planning Commission (SRPC), a political subdivision of the State of New Hampshire, serves in an advisory role to the Town of Newmarket and seventeen other member communities. We provide professional planning services to help officials, boards and citizens manage growth and to facilitate regional collaborative efforts.

SRPC's professional staff offers a range of planning services in transportation; land use, conservation, natural resources, economic development, downtown revitalization, and geographic information systems (GIS) mapping and analysis. These services are available in customized modes to meet the diverse needs of the volunteers who are the foundation of communities. Our member communities also have access to additional SRPC educational resources including our website, newsletter, library, guides, workshops, forums, and personalized training.

SRPC conducted the following projects and initiatives for Newmarket in 2007:

- Provided GIS mapping and training services to Town staff.
- Created a set of large format standardized maps.
- Updated the Town's digital tax parcels and printed a new set of tax maps.
- Assisted Town staff with funding requests for transportation projects.
- Provided procedures for Regional Impact Review and technical assistance for Town Planner.
- Created a comprehensive GIS land use data layer, identifying categories of land use in town.
- Conducted 5 traffic counts in Newmarket.

SRPC also provided the following services to Newmarket and other municipalities in 2007 including:

- Established a Regional Impact Committee, which reviewed 3 developments determined by local Planning Boards to have potential regional impact.
- Coordinated communities' responses to the NH Ten Year Transportation Plan.
- Hosted a Riparian Buffer Workshop to help communities protect water quality.
- Updated the Regional Travel Demand Model for traffic modeling and air quality conformity
- Prepared Model Drinking Water for Protection of Surface Water Supply Areas Ordinance as part of the *Innovative Land Use Planning Techniques*.

- Distributed *New Hampshire Planning and Land Use Regulation* books to all local land use boards.

Online Payments. Currently 1,035 people use the Town's online bill payment service available at www.newmarketnh.gov. Motor vehicle registration renewals, water/sewer bills, and property taxes may be paid using a bank account, DiscoverCard, MasterCard, or American Express.

Motor Vehicle and Boat Registrations. Beginning February, 2008, we will have the ability to provide expanded motor vehicle registration services within our Office, Conservation (moose) and vanity plates. Late renewals, replacement plates, certified registration copies, over-weight vehicles, gift certificates will be available. Providing these new services will generate additional Town revenue. Registrations will continue to be processed (up to 4 months in advance) at the counter, through mail-ins, and online. Courtesy reminders are mailed prior to renewal months.

Property Taxes. *The property tax year is April 1 to March 31.* Taxes are billed twice yearly, and are generally due July 1 and December 1. The July bill is an estimate based on one-half of the previous year's total tax. The State of NH sets our tax rate in the fall based on the Town/School/County approved budgets. The December bill (second half tax) reflects any increase/decrease necessary to collect the full amount set by the State. Any unpaid taxes or water/sewer bills are secured by the placement of a lien on the property. This lien has priority over all other liens and is generally executed in April. Liens accrue interest at the rate of 18%. If the property lien is not redeemed within 2 years, the property is tax deeded to the Town.

Vital Records. Civil Unions became legal on January 1, 2008. Newmarket recorded the third Civil Union in the State on January 2. Any NH birth certificates—1988 to present, NH death certificates—1990 to present, NH marriage certificates—1989 to present, and NH divorce—1990 to present, can be obtained through our Office. Earlier Newmarket birth, death, and marriage records are also available. Fees are \$12.00 for the first certificate and \$8.00 for additional identical certificates ordered simultaneously. Marriage and Civil Union licenses are \$45.00.

Vital Record Preservation Grant. We applied for and received a \$10,000 grant from NH's Vital Records Improvement Fund, resulting in major improvements to our records storage environment, security, and equipment. We have reformatted, re-housed, and conserved Newmarket's vital records dating back to the late 1700s.

Dogs must be licensed by April 30th each year. Fees are \$10.00, male/female dogs; \$7.50, spayed/neutered dogs and puppies, and \$3.00, first dog owned by a senior. Failing to register by June 20 may result in a \$30.00 civil forfeiture fees per dog.

Water & Sewer bill payments are received and processed in our office.

Other services include: voter registration, facilitating and carrying out elections; transfer station coupons; trash bags; recycle bins, tax map copies, town regulations, burner permits, wetland applications, peddler permits, and notary public.

Resident Tax was repealed by the Town Council effective April 1, 2008.

Staff. Donna Dugal continues to serve as full-time Deputy Town Clerk and Tax Collector. Along with her, I am extremely fortunate to have the excellent part-time assistance of Deb McCain and Becky Uhlenberg. All combined, their professionalism and 'service with smiles' trademark are truly an asset to our community—I am very proud to be associated with them!

Office Hours are Monday—7:00 a.m. to 7:00 p.m., Tuesday through Thursday—8:00 a.m. to 4:30 p.m., and Friday—8:00 a.m. to 12 Noon. (Please be reminded there is a secure 24-hour payment drop box located on the right-hand side of the Town Hall building.)

Thank you for the opportunity to serve you, the residents of Newmarket. Providing excellent customer service is our goal, and we hope to continue finding ways to improve and enhance your experiences with us. Please feel free to contact us—your suggestions are welcome!

Upon written request from the governing board, you must provide an itemized list of the uncollected and unredeemed taxes at the end of the fiscal year. It should contain the name of and the amount due from each delinquent taxpayer.

TAX COLLECTOR'S REPORT - FORM MS-61

At the close of the fiscal year, each tax collector is required to submit a written report to the municipality. The report, the form MS-61, is sent to the Department of Revenue Administration by the last day in February (August 31 for June year end) and must also be published in the annual report. It summarizes the activities in your various accounts. The report must contain not only a summary of the current year's tax levies, but also separate summaries showing the activity in all prior year's tax levies which are not settled at the end of the fiscal year.

Please fill in your town name and the year of the report. Specify the year in the column headings. We have given instructions for the financial report form MS-5 to the selectmen. Those instructions require the selectmen to obtain tax collector accounts information from your report.

Blank categories are provided for those who wish to report in more detail. The total of page 1 should equal the total of page 2, and debits on top of page 3 should equal the credits on the bottom of page 3. The column heading on page 3, "Last Year's Levy", refers to the levy for the year prior to that for which the form is being completed. For example, if in January 2005 you are completing this form for year end December 2004 the report is for 2004 and "Last Year's Levy" would be the levy for 2003.

Sign on page 3 and return one copy to us at the address below and give a copy to your governing body (selectmen). They are required to publish your report in the municipality's annual report.

ANNUAL TOWN MEETING NEWMARKET NH

FIRST SESSION: APRIL 10, 2007

Moderator Clay Mitchell of 5 Hilton Drive called the meeting to order at 7:04 p.m. The Pledge of Allegiance was recited. Approximately 75 registered voters were in attendance. The Warrant and Budget, as approved by the Town Council, was distributed along with several other supporting documents.

Moderator Mitchell presented the Warrant and explained the manner in which he would conduct the meeting, noting all Warrant Articles, unless amended, would simply be put forth, as written, on the official ballot to be voted on May 8, 2007, the Second Session of the 2007 Annual Meeting.

Moderator Mitchell then requested, and all observed, a moment-of silence in honor of all who have served our country in wars, conflicts, and locally in times of need such as the recent floods.

Article 1. To choose all necessary Town Officers for the ensuing year.

Budget Committee	Three for three (3) years One for two (2) years One for one (1) year
Planning Board	Two for three (3) years One for One (1) year
Town Council	Two for three (3) years
Trustee of Trust Funds	One for three (3) years

There being no discussion, Moderator Mitchell stated Article 1 would be put forward as written.

Upon a **motion** duly made by David Bird of 42 Smith Garrison Road and seconded by William Conner of 295 Wadleigh Falls Road, it was **VOTED** by a show of hands (41 in favor and 28 opposed) as follows. (Mr. Bird provided Moderator Mitchell with a copy of the motion.)

To bring forward Warrant Article 11 to be considered prior to consideration of Article 2.

Article 11. Operating Budget.

Shall the Town raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling nine million three hundred ninety-three thousand, seven hundred sixty-one dollars (\$9,393,761). Should this article be defeated, the operating budget shall be nine million one hundred twenty-five thousand, two hundred fifty dollars, (\$9,125,250), which is the same as last year, with certain adjustments required by previous action of the Town of Newmarket, or by law, or the Town Council may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.

Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 11. Town Administrator Alphonse Dixon presented an overview of the 2007/2008 operating budget, noting the proposed budget could result in 26 cents per \$1,000 tax increase. He also noted it is possible the projected increase could shrink to 10 cents or below. David Bird asked how the Town was able to spend down the tax rate for 2006. Mr. Dixon explained that at tax rate setting time, there are possible adjustments in revenues, and determinations are made regarding what is appropriate to use of the fund balance to keep the tax rate down.

Edward Portyrata of 177 Exeter Road questioned information he had heard regarding the State of New Hampshire retirement system and asked if this would affect Newmarket. Mr. Dixon responded it is anticipated there will be a 28% increase in the retirement costs, noting that the program is currently in a crisis situation.

Samuel J. Fitzpatrick of 9 Osprey Lane said that in reviewing the budget and the separate warrant articles that the possible tax increase could be 37 cents per \$1,000. He questioned the rationale of having all the separate warrant articles. Councilor Brian Hart responded as a Council member to the Budget Committee, and said the decision was made to separate new items from the budget into separate warrant articles in order that the voters could determine whether these new expenditures should be approved.

There being no further discussion, Moderator Mitchell stated Article 11 would be put forward as written.

Article 2. Police Department Systems Administrator

To see if the Town will vote to raise and appropriate the sum of \$47,918 (salary & benefits) to fund a new position entitled Systems Administrator, to provide support services in the Police Department.
(Tax rate would increase by approximately \$.06 per thousand this year.) (Majority ballot vote)
Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 2. Police Chief Kevin Cyr presented an overview and background information about why the Article was deemed necessary. He noted the number of police officers had doubled since the 1970s, that the workload had increased 10-fold, and that the number of dispatchers had not increased. He also explained how the use and improvements in technology and automation had made this possible. Chief Cyr reported he is currently managing the automated systems used by the Police Department with assistance from various officers and the Town's MIS Manager. The Department is in need of an exclusive Police Department employee to manage the multi-systems in order to return the officers to duty on the street and to keep the dispatch center running. It was also pointed out by Councilor Michael Ploski that due to the sensitive and private information handled by these systems, under the various operating system contracts, only a Police Department employee who is directly and exclusively supervised by the Chief, is allowed to have access to these systems.

Peyton Carr of 213 Bay Road questioned why proposed expenditures such as this would be separated into a separate warrant article since it is not a one-time expense. Budget Committee Rod Bowles explained that since the program is new, the intent was to obtain voter approval, then in continuing years the expenditure would be incorporated and managed in the regular budget process.

There being no further discussion, Moderator Mitchell stated Article 2 would be put forward as written.

Article 3. Mosquito Control Services

Shall the Town raise and appropriate the sum of Sixty-six Thousand Two hundred Dollars (\$66,200) to provide mosquito control services as follows: (1) Larvaciding (\$39,000) (2) Adulticiding (control flying mosquitoes by truck in emergencies only) (\$22,200) (3) Adult mosquito collection and testing (\$5,000)
(Tax rate would increase by approximately \$.09 per thousand this year.) (Majority ballot vote)
Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 3. Administrator Alphonse Dixon reported that this is the same warrant article as was approved by voters last year, noting the extensive debate surrounding this issue last year. Mr. Portyrata questioned if it is already too late to start the program and whether it is a private company providing the services. Mr. Dixon reported that the private company is Municipal Pest Management, and the owner Mike Morrison was present at the meeting to answer any questions. Councilor Brian Hart explained it is not too late, since the program and monies were approved last year to ensure that the program is already funded through June 2007. He noted this warrant article would provide monies from July 2007 to June 2008.

Ellen Conner of 295 Wadleigh Falls Road questioned whether the program would be carried out in specific areas of Town or throughout the entire Town. Administrator Dixon responded that it will be carried out in all 'hot spots', which included only stagnant shallow bodies of water, not rivers.

There being no further discussion, Moderator Mitchell stated Article 3 would be put forward as written.

Article 4. Multiple year Police Department Collective Bargaining Agreement

To see if the Town of Newmarket will vote to approve the cost items included in the collective bargaining agreement reached between the Town Council and the International Brotherhood of Teamsters, Local 633 which calls for the following increase in salaries and benefits at the current staffing level:

Year	Estimated Increase
FY 2007-08	\$108,209
FY 2008-09	\$ 86,391
FY 2009-10	\$ 87,681

And further to raise and appropriate the sum of \$108,209 for the current fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits over those of the appropriation at current staffing levels paid in the prior fiscal year.

(Tax rate would increase by approximately \$.15 per thousand this year). (Majority ballot vote.)

Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 4. Council Chairwoman Jennifer Jarvis reported that an agreed-upon contract had been negotiated with the Police union. She highlighted the "Key points contained in the negotiated Police Contract (copies of which were available for attendees).

Mr. Portyrata requested additional information regarding the health insurance coverage and premiums and what specifically is included in the \$108,000. He also noted he had obtained a copy of Town payroll records. Council Chairwoman Jarvis noted that the police had not received any pay increase since 2004, and that the \$108,000 included an amount to make up a retroactive increase. She reported that a police officers were entitled to pay increases of up to 5 percent, which is in keeping with regular town employees. Mr. Dixon reported that the \$108,000 does not include health insurance or retirement costs since there was no negotiated change in these benefits (i.e., no added cost). Budget Committee member Rod Bowles pointed out that the payroll records reflected and included all hours and wages, noting that many of the police officers have worked extra details and overtime in order to supplement their regular 40 hour pay period.

David Bird questioned if the negotiated contract resulted in less of a pay raise than if the police and remained non-union. Officer Richard Beaudet of 245 Grant Road stated that this may be true. He reiterated that the 5% for police is equivalent to the 3% plus COLA of up to 2% that the regular town employees receive.

Chief Cyr clarified Mr. Portyrata's interpretation of the payroll records he was citing, noting there are not any police officers earning anything close to \$100,000, as Mr. Portyrata stated. He also pointed out that the retirement benefits and program that the Newmarket police department is receiving are exactly the same NH retirement benefits and program that all other police departments in the State are receiving.

Councilor Brian Hart, also a member of the Town's negotiating team, pointed out they were very thankful for two concessions made by the union: 1) arbitration is non binding, and 2) performance evaluation and merit pay system. Councilor Hart is unaware of any other police unions who have agreed to this. He also indicated the Council is hopeful of incorporating the evaluation and merit pay system into the Town's regular policies for its other employees.

Debbie Hale of 231 South Main Street spoke noting she is a federal employee and raised concerns about the union pay scale being different than the pay scale for regular, non-union employees. Council Chairwoman Jarvis said the Council hopes to continue with the same merit plan for all town employees.

There being no further discussion, Moderator Mitchell stated Article 4 would be put forward as written.

Article 5. Authorization for Special Town Meeting on Defeated Collective Bargaining Agreement Warrant Article

Shall the Town of Newmarket, if Article 4 is defeated, authorize the Town Council (governing body) to call one special town meeting, at its option, to address Article 4 cost items only?
(majority ballot vote)

Moderator Mitchell read Article 5.

There being no discussion, Moderator Mitchell stated Article 5 would be put forward as written.

Article 6. Appropriation for Fire Ladder Truck Capital Reserve

To see if the Town will vote to raise and appropriate the sum of Twenty five Thousand dollars (\$25,000) to be deposited in the Fire Ladder Truck Capital Reserve Account established under the provisions of RSA 35:1.

(Tax rate would increase by approximately \$.03 per thousand this year) (Majority ballot vote)
Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 6. Budget Committee Member and Member of the Capital Improvement Program (CIP) Committee Robert Coffey reported the CIP Committee had requested this be placed on the Warrant. He noted the CIP Committee had opted to keep capital spending overall the same as last year.

There was considerable discussion about this article. Douglas Hamilton of 33 Lamprey Street noted that two years ago \$50,000 was approved by the voters and questioned if the \$50,000 was not put aside. Mr. Coffey stated Mr. Hamilton was correct; it was not put aside. Mr. Hamilton questioned if the Council was choosing to negate the wishes of the Town and questioned why the Town would be required to vote again on what was already voted on two years ago. He said he felt there should already be \$50,000 in an account. He also questioned whether this might set some sort of precedence.

Councilor Hart reported the \$50,000 was appropriated and the \$50,000 was in capital reserves right now. He noted the proposed Fire Department live-in program that was put on the warrant last year failed. He said no additional monies related to a ladder-truck were added last year due to the live-in proposal request. He reported the Council, which was not unanimous regarding this issue, felt this item, in the amount of \$25,000, should be put forth separately to the voters again this year. He also said the town is not legally obligated to increase the fund each year based on the vote two years ago.

Mr. Hamilton reported that three recent grant applications were unsuccessful in obtaining funds that could be used toward a ladder truck. He questioned why monies are not being put in the CIP plan.

Richard Alperin of 204 South Main Street, requested a presentation from the Fire Department outlining why the Town needs a ladder truck. Fire Chief Richard Malasky responded with a detailed explanation. He noted the ISO (Insurance Service Office) evaluates the Police Department, Dispatch, and Fire Department, and reviews the water supply, structures and number of structure stories. According to the ISO, if a community has at least 5 buildings that are more than 35 feet tall, an aerial fire fighting device is necessary. Chief Malasky reported that Newmarket has over 44 buildings that are greater than 35 feet in height. He noted specifically the Bryant Rock condominiums, Bennett Way buildings and several buildings located on Main Street. Chief Malasky reported that Newmarket currently has a 5.9 ISO rating. He said if Newmarket were able to obtain a 4.9 rating, it could provide everyone in Town with insurance premium savings of 3 to 5 percent. Obtaining an aerial fire fighting device would result in lowering the Town's ISO rating by 5 points. This, plus updating and improving the Town's water mains, which would improve fire flow water volume, could possibly achieve a 4.6 rating. He also emphasized that having full-time fire fighters is not a requirement. To meet the requirements, the fire station must be within 2 ½ miles from tall buildings, which is currently the case. Chief Malasky further noted the current response time using Durham or Exeter's aerial fire fighting equipment is 15 to 25 minutes.

Mr. Hamilton noted he has been an insurance underwriter for 32 years, and he spoke of the advantages of a community having a lower class rating, i.e., more companies could offer better coverage at more affordable rates.

Mr. Portyrata asked if impact fees can be used to fund a ladder truck. Council Chairwoman Jennifer Jarvis reported that the Town does not have impact fees for fire and rescue.

John Deziel of 64 Packers Falls Road spoke about his extensive grant writing experience and indicated he has been assisting the Fire Department with grant applications. He noted he had obtained a letter from Congressman Jeb Bradley in support of Newmarket obtaining a fire ladder truck. He is also working with Congresswoman Carol Shea Porter in a similar effort. He requested the Newmarket Town Council consider submitting a similar letter of support, noting the Council's support is necessary to most effectively apply for funds. He offered to work with anyone to write grants and noted that, as Jeb Bradley's letter states, obtaining a fire ladder track would: 1) be a cost savings to the Town in terms of decreased insurance premiums, 2) benefit the human element in terms of saving lives, and 3) be a positive marketing tool to increase investments in the downtown area.

Mr. Carr questioned if it would be possible for the Town Council to consider implementing an impact fee program for this purpose. Council Chairwoman Jarvis said that, with the Council's support, she would put this on as a future Council agenda item.

It was questioned whether the wording of Warrant Article 6 is sufficient and whether the Town will have to repeat a similar warrant article again in the future. Councilor Hart reported that it would not necessarily have to be a separate warrant article, it could be possible to add it through the CIP program. Mr. Coffey recommended that any interested parties attend a future CIP Committee meeting next fall to voice their opinions regarding the funding of a ladder track. He noted the Committee begins meeting in September and meets every two weeks through the fall.

There being no further discussion, Moderator Mitchell stated Article 6 would be put forward as written.

Article 7. Bridge Improvement Capital Reserve

Shall the Town vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of improving and rebuilding existing bridges, and constructing new bridges; and raise and appropriate the sum of Ten Thousand dollars (\$10,000) to be placed in said fund and to appoint the Town Council as agents to expend from the Bridge Improvement Capital Reserve.

(Tax rate would increase by approximately \$.01 this year) (Majority ballot vote)

Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 7. Budget Committee and CIP Committee member Robert Coffey gave a brief overview.

There being no discussion, Moderator Mitchell stated Article 6 would be put forward as written.

Article 8. MacAllen Dam Capital Reserve

Shall the Town vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of maintaining and improving the MacAllen Dam in Newmarket; and raise and appropriate the sum of Ten Thousand dollars (\$10,000) to be placed in said fund and to appoint the Town Council as agents to expend from the MacAllen Dam Capital Reserve.

(Tax rate would increase by approximately \$.01 this year) (Majority ballot vote)

Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 8. Budget Committee and CIP Committee member Robert Coffey gave a brief overview.

Mr. Hamilton asked if the dam is federally inspected. Chief Malasky responded that the dam is inspected by the State of New Hampshire. He said currently there are mechanical issues related to the gates which need to be addressed, but overall the dam is in good shape.

Councilor Dana Glennon reported that the dam is owned by the Town of Newmarket and was obtained by the Town through its acquisition of the MacAllen properties.

Mr. Portyrata questioned if Newmarket had approached other surrounding towns to assist with the upkeep of the dam. Administrator Dixon responded that this had not been pursued and in his experience, other towns were not very receptive to agreeing to contribute to another town's financial needs. He also noted that the Town of Durham may have similar needs with regard to the Wiswall Dam.

There being no further discussion, Moderator Mitchell stated Article 8 would be put forward as written.

Article 9. Town Cemeteries Capital Reserve

Shall the Town vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of maintaining and improving Town Cemeteries, and raise and appropriate the sum of fifteen thousand dollars (\$15,000) to be placed in said fund and to appoint the Town Council as agents to expend from the Town Cemetery Capital Reserve.

(Tax rate would increase by approximately \$.02 this year) (Majority ballot vote)

Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 9. Administrator Dixon noted that two years ago a 5-member Board of Cemetery Trustees was established, and they have been working toward improving the town's cemeteries. Administrator Dixon explained that originally the Board had requested \$25,000 which included removing trees from the cemetery immediately behind the Police Department building. He said \$10,000 of that request has been incorporated in the operating budget. Cemetery Trustee member Richard Alperin explained that the \$15,000 is being requested for improvements and repairs to this cemetery. He also noted that information hand-outs were available to attendees.

Amy Thompson of 109 Langs Lane questioned if the wording of the article should be amended. She noted that the wording did not specifically require that the funds be expended for this particular cemetery. Administrator Dixon confirmed that the wording would theoretically allow for the funds to be used for any town cemetery, but the Committee has identified this cemetery as its priority. Mr. Alperin stated it is estimated it could cost as much as \$50,000 to \$75,000 to repair all the monument stones in this cemetery.

There being no further discussion, Moderator Mitchell stated Article 9 would be put forward as written.

Article 10. Establish Expendable Trust Fund—Special Warrant Article

To see if the Town will vote to create an expendable trust fund under the provisions of RSA 31:19-a, to be known as the Newmarket Veterans Memorial Expendable Trust Fund, and appoint the Town Council as agents to expend funds from the Newmarket Veterans Memorial Expendable Trust Fund, for the purposes of repairing and maintaining existing War Memorials and to fund the development and construction of new memorials to honor our war veterans, and to raise and appropriate the sum of ten thousand dollars (\$10,000) to be placed in this fund. (tax rate would increase by approximately \$.01 this year) (Majority ballot vote)

Recommended by the Town Council and recommended by the Budget Committee.

Moderator Mitchell read Article 10. Budget Committee member and CIP member Robert Coffey explained that this warrant article was requested to take care of the existing monuments, and he noted that the Committee does have ideas about putting up new monuments.

There being no further discussion, Moderator Mitchell stated Article 10 would be put forward as written.

Article 11. Operating Budget (considered prior to Article 2 – see above).

Article 12. New Hampshire Climate Change

To see if the Town will go on record in support of effective actions by the President and the Congress to address the issue of climate change which is increasingly harmful to the environment and economy of New Hampshire and to the future well being of the people of Newmarket. These actions include:

1. Establishment of a national program requiring reductions of U.S. greenhouse gas emissions while protecting the U.S. economy.
2. Creation of a major national research initiative to foster rapid development of sustainable energy technologies thereby stimulating new jobs and investment.

In addition, the Town of Newmarket encourages New Hampshire citizens to work for emission reductions within their communities, and we ask our Town Council to consider the appointment of a voluntary energy committee to recommend local steps to save energy and reduce emissions.

The record of the vote on this article shall be transmitted to the New Hampshire Congressional Delegation, to the President of the United States, and to declared candidates of those offices.

Moderator Mitchell read Article 12. Councilor Brian Hart explained that this warrant article was the result of a Petitioned Warrant Article. He noted that the Council had also previously passed a separate, but similar, resolution because it believes the federal government needs to take more initiative to address these climate change issues.

There being no further discussion, Moderator Mitchell stated Article 12 would be put forward as written.

Article 13. Other Business

To transact any other business which may legally come before this meeting.

2007 Town of Newmarket First Deliberative Session

Moderator Mitchell recognized the employees and volunteers of the Police Department, Fire Department, and Emergency Services for their outstanding efforts during this past year's flood. All those in attendance showed their appreciation with a round of applause.

There being no further business, the meeting was adjourned at 12:07 a.m., April 12, 2006.

Article 7. Public Safety Services Revolving Fund

To see if the town will vote to create a Public Safety Services Revolving Fund, in accordance with RSA 31:95-h, I(c), to name the Finance Director as agent, or the Town Administrator if the Finance Director position is vacant, of said fund and to deposit all funds received for Police and Fire details, plus administrative fees, each year into such fund beginning July 1, 2008. In accordance with RSA 31:95-h, II, with the creation of the Public Safety Services Revolving Fund, the monies received from fees, charges or other income derived from the activities or services supported by the fund shall be deposited in the fund. The money in the fund shall be allowed to accumulate from year to year, and shall not be considered part of the town's general surplus. The Town Treasurer shall have custody of all monies in the fund, and shall pay out the same only upon the order of the Town Administrator. These funds may be expended only for the purposes stated in RSA 31:95-h, I(c), and no expenditure shall be made in such a way as to require the expenditure of, or create a liability upon, other town funds which have not been appropriated for that purpose. After creation of such Public Safety Services Revolving Fund, the monies in such fund shall not need further town meeting approval to be expended.

Article 8. Charter Amendment – Fiscal Affairs; Treasurer; Investment Advisor; Audit

Section 4.15 Fiscal Affairs; Treasurer; Investment Advisor; Audit.

D. The Town Council shall, after inviting requests for proposals and appropriate verifications of qualifications, experience and integrity, select a certified public accountant or firm of same who shall perform an annual audit of all town financial transactions after the close of each fiscal year. Said audit shall include all revenues, expenditures and accounts maintained by any officer, elected or appointed, agency, board, commission, or recipient of Town funds; may include a compliance audit to insure conformity with any State or Federal laws and regulations and Town work programs and policies; and shall include a management letter setting forth recommendations for changes and improvements in finance management systems as is deemed necessary. For purposes of cost and efficiency, an auditor may be retained for a period of years, but requests for proposals shall be sought at least once every five (5) **three (3)** years, and a new auditor shall be selected at least every ten (10) **six (6)** years. Nothing contained herein shall prohibit the Town Council from ordering an entire audit, partial audits, or

interim audits more frequently than once per year as it may deem prudent. Summaries of annual audits, when available in a timely manner, shall be printed in the annual Town Report and complete copies shall be available for public inspection and copying in the Town office during normal business hours. If a summary of an annual audit is not available for printing in the Town Report, said summary shall be made available at the Town Meeting or as soon thereafter as practicable.

Article 9. M-1 District Zoning Change

To see if the Town of Newmarket will ordain and amend the Newmarket Zoning Ordinance to:

Add to the existing Table of Uses an "X" on the row for "Multi-family residential" under the column for the M-1 District so that "multi-family residential" is an allowed use as a matter of right in the M-1 District.

Change the Dimensions Table by adding an asterisk to the current 20 units per acre under the column for the M-1 District and an asterisk noted below the Table to reflect that the maximum residential density in existing mill buildings in the M-1 District which have previously not been finally approved for redevelopment prior to the effective date of this amendment is increased to 40 units per acre.


Add to Section 2.01 (B) (1) concerning permitted uses within the M-1 District the following new subsection (a): For projects redeveloping existing mill buildings which have previously not been finally approved for redevelopment prior to the effective date of this amendment, it is expressly consistent with the public interest and with the spirit of this ordinance that the areas of lots on the west side of Route 108 which are owned by or otherwise available by agreement of the applicant/developer, whether in whole or in part, be used for parking for the redevelopment of such existing mill buildings, and that such lot areas be include in the project for purposes of density calculations.

This warrant article is non-binding and advisory only. Its passage will not amend the Town of Newmarket Zoning Ordinance.






